Remember, the fair is now using ShoWorks, which does have a ShoWorks App that you can download to complete entries too. You can still enter through the ShoWorks website, but you will need to create a new account. Market Swine Weigh-In

Market Swine Weigh-In will take place on **Friday, May 6th from 5-9pm** in the TRP Barn at the Ag Center. If you have any specific questions about weigh-in, please contact the Extension Office or one of the Swine Committee Members. Please remember to check all of your paperwork prior to leaving weigh-in. Once you leave the Ag Center, we will not be able to make any changes.

Castration Policy of the Maryland 4-H AnSc Program: All male steers, lambs, pigs and goats must be neutered and healed prior to 4-H weigh-in and tagging. The only exception would be animals that have obvious signs they have been banded, however, their scrotal sac is still intact.

Market Sheep and Goat Weigh-in and Tagging

If you plan to exhibit one of the above animals at the county or state fair, it must have a Maryland 4-H ear tag and be weighed in Carroll County. You must turn in a completed 2-part form to the Extension Office with the number of tags you will need by **May 6th (Weigh-in Date – Friday, May 13th, 5-8 P.M.)**. Remember to fill in ALL information, including RFID/Scrapie tag numbers. The Animal Science Code of Ethics will be on the reverse side and BOTH pages must be signed. **Tags cost \$2 for lambs and goats.** Checks can be made payable to CCEAB. You must register, tag and weigh-in the appropriate animal for Carroll County. You may not weigh-in your animals in another county and be eligible for the Carroll County 4-H/FFA Fair. Questions? Castration Policy of the Maryland 4-H AnSc Program: All male steers, lambs, pigs and goats must be neutered and healed prior to 4-H weigh-in and tagging. The only exception would be animals that have obvious signs they have been banded, however, their scrotal sac is still intact.

Livestock Sale Update

ALL 2022 Carroll County 4-H & FFA Livestock Sale Exhibitors are responsible for transporting their 4-H & FFA Livestock Sale project to the processor of their buyers choosing. Please read the attached information carefully (you will sign a carbon copy form at weigh-in or when you submit livestock registration forms). All exhibitors will be required to sign and return the form if they intend to sell in the CC 4-H & FFA Livestock Sale. In addition, the Livestock Sale Committee voted to decrease their commission from the original 6% to 5%. Hopefully, this will help exhibitors offset transportation costs to processors. Finally, beginning this year, the **CC 4-H & FFA Livestock sale will start at 4:30pm**. Scholarship awards will start at 3:30pm. The buyers picnic will run from 5-7pm. Animal Quality Assurance

If you are a new member or have moved to a new age group (Junior to Intermediate, Intermediate to Senior), you are required to take the online Quality Assurance Program this year. The online program is required for ALL 4-H members showing beef, dairy, swine, sheep, goats, horses/ponies, poultry, rabbits and alpacas/llamas. An email will be sent when the website (<https://ahqa.umd.edu/>) is opened by Maryland 4-H. You will need to register and complete this program if you are planning to show at any 4-H show. If you have questions, please contact Becky at bridgewa@umd.edu. Quality Assurance must be completed by **Friday, July 22nd to be eligible to show** at the Carroll County 4-H/FFA Fair.

4-H Leadership Council Meeting

Project Record—2022 Update of Requirement

In 2022, all project records that are completed will be held to meeting all standards, including the communication section. Remember, that 4-Hers must present a speech or demonstration to 3 or more people not related to them to meet this requirement. *This is a speech or demonstration the youth has given, not something they attended.* Don't forget that participating in programs such as skillathon, bowls, and judging programs count toward this requirement. The Extension Office has been lenient of this project record requirement since 2020, but with clubs and programs happening again in-person, all project records submitted MUST have a communication piece. Maryland Park Service Youth Group Pass

The office now has a Maryland Park Service Youth-Group Pass available for check-out! Call the office to learn more!

The Maryland Park Service Youth-group Pass allows free day-use entry into Maryland state parks. The pass also entitles youth groups to camp in those parks that have designated youth group areas, subject to site availability. In order to camp, all groups must have a valid Maryland Park Service Youth-group Pass and must make a reservation.

A few things to be aware of:

- Usage excludes weekends and holidays from Memorial Day through Labor Day.
- Maryland Park Service reserves the right to restrict the maximum number of vehicles and individuals admitted under one Youth-group pass per visit.
- A minimum ratio of one adult supervisor for every five youth is required (may be waived by the facility manager).
- The minimum allowed age of group members is 6 years old and the maximum allowed age of group members is 18 years old.
- Family members that are accompanying the group but not part of the leadership of the group may be subject to additional service charges.
- Service charges for special facilities such as shelters, boat concessions, reservations and special events are not covered by the youth pass.

UME Volunteer Training

If you aren't already a UME Volunteer, make plans to complete the training in 2022. Just email Becky (bridgewa@umd.edu) and you can complete all of the required paperwork and training directly from your home. Trainings can be completed at anytime!

UME Volunteers

When completing the volunteer enrollment, remember this is a two-step process. Step 1 is the enrollment which leads into step 2, the screening process.

Please note that the state will be approving the screening section of all volunteers once the background checks have been completed and before the county office can approve enrollments. **Please make sure to meet the March 1st deadline of completing your enrollment to be covered under the Maryland Tort Claims Act which provides you coverage (if ever needed) as a UME Volunteer.**

Also, we are required by UME/Maryland 4-H volunteer policies to have volunteer position descriptions signed every 3 years. Many volunteers will need to resign their position descriptions. Be on the lookout in your mail and return to the Extension Office to ensure that we have all your information up to date in the office.



University of Maryland Extension (UME) 4-H Code of Animal Science Ethics

4-H members enrolled in animal science projects (e.g., beef, camelids, dairy, dog, goat, horse, poultry, rabbit, sheep, small pet, and swine) shall, at all times, conduct themselves with honesty and good sportsmanship, including while with their projects and at all 4-H animal science activities and events. Their conduct should always reflect the highest standards of honor and dignity to promote the advancement of 4-H and its animal science program. 4-H members, as well as parents, UME volunteers and others working with them, are under an affirmative responsibility to do more than avoid improper conduct or questionable acts; and their conduct and values must serve as a positive influence on others.

This Code of Ethics applies to all 4-H members who are enrolled in animal science projects, and to others (4-Hers, parents, volunteers, owners, etc.) who participate in the animal science program; and it covers daily animal care, as well as participation in competition and other 4-H animal activities and events.

4-H members and others who violate this Code of Ethics demean the integrity of 4-H and its animal science program. 4-H members who violate the code of animal science ethics are subject to sanctions including, but not limited to, forfeiture of premiums, awards, and/or auction proceeds and may be prohibited from participation in 4-H or 4-H/UME events or activities; other violators may also be subject to sanction, as appropriate. Infractions may be reviewed by 4-H and/or UME (on the local or state level, as appropriate to the infraction and to the event and/or activity in question), and/or may be subject to a fair oversight committee or other entity that oversees an activity or event. In addition, some acts may also be subject to review based upon the *Maryland 4-H Youth Code of Conduct* and/or other UME policies.

The following is a list of standards and requirements for all 4-H animal science projects, at all times, whether at home, at animal exhibitions or events, or any other 4-H event or activity.

1. The care of all 4-H project animals is the responsibility of the 4-H member. 4-H members must properly care for and groom their animals for the duration of their project.
2. All project animals must be housed at the 4-H member's residence unless a different location is submitted to and approved in writing by the local 4-H staff. Any change in location must be approved in writing by the local 4-H staff; however, it is not necessary to report direct transport to and from shows or other events.
3. Upon request of 4-H, UME, or other program, fair, event or animal officials, 4-H members must present proof of ownership, length of ownership, identity and/or age of all 4-H project animals owned or leased. Misrepresentation of ownership, age, or identity of animal, or any facts relating thereto is prohibited. If a 4-H project animal is sold in a livestock sale, it is no longer eligible to be shown in a 4-H event in Maryland in that year.
4. 4-H members must provide appropriate animal health certificates upon request of 4-H, UME, or other program, fair, event or animal officials.
5. 4-H project animals must be presented to competition, activities and/or events, where they will enter the food chain, free of volatile drug residues. Animals which are presented to competition, events and/or activities that do not culminate with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal, state, and local laws, regulations and rules. 4-H project animals shall not be exhibited if drugs administered in accordance with federal, state, and local regulations and rules may affect the animal's performance or appearance at the event. At any time after an animal arrives on a fair or other 4-H activity or event premises, a licensed veterinarian must administer or, in consultation with fair, event, UME, or 4-H officials, direct the administration of any treatments involving the use of drugs and/or medications. Drenching at any time after an animal arrives on a fair or other 4-H activity or event premises is prohibited, except when performed or directed by a licensed veterinarian in consultation with fair, event, UME, or 4-H officials for the sole purpose of protecting the health of the animal.
6. The act of enrolling in a 4-H animal science project, and/or entering a project animal in a 4-H competition, show, activity, or other event, gives consent for 4-H or UME or event authorities to obtain any specimens of urine, saliva, blood, hair, tissue, or other substance from the animal to be used for testing purposes including, but not limited to, drugs or identification. It is presumed that the sample of urine, saliva, blood or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved, and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the 4-H owner to prove otherwise at any review in regard to the matter conducted by a fair or other event or the 4-H program. If the laboratory report on the chemical analysis of saliva, urine, blood, hair, tissue or other sample, taken from a 4-H animal science project, indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally.
7. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counter irritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
8. Using ice, ice packs, cold packs, or cold compresses, internally or externally, other than those prescribed to relieve heat stress or a medical condition as diagnosed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
9. The use of showing and/or handling practices or devices, such as striking animals to cause swelling, using electrical devices, or other similar practices, are not acceptable and are prohibited.
10. All judges, fair and event officials and/or UME/4-H staff and volunteers shall be treated with courtesy, cooperation, and respect, and no person shall direct abusive or threatening conduct toward them or toward exhibitors or others participating in the activity. In addition, direct criticism or interference with a judge, fair, show or event official, exhibitor, breed representative, or UME/4-H staff or volunteer before, during, or after an event or other activity is prohibited.
11. No one shall violate this Code of Animal Science Ethics or conspire with another person or persons to intentionally violate this Code of Ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this Code of Ethics.
12. The application of this Code of Ethics provides for absolute responsibility for an animal's condition to the 4-H member whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this Code of Ethics.
13. By enrolling in an animal science project and/or entering an animal in a fair or other 4-H event or activity, the 4-H member, and his/her parent or guardian, consent to have disciplinary action taken by appropriate authorities (including UME, 4-H, fair, event and/or other activity officials) for violation of this Code of Animal Science Ethics and/or any other applicable rules of UME, 4-H, a fair, activity or other event, without recourse against UME, 4-H and/or other authorities. In addition, the 4-H member, and his/her parent or guardian, further understand and agree that any action which contravenes these rules, and is also in violation of federal, state, or local laws, statutes, regulations, or rules, may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

By signing this form the 4-H member and his/her parent or guardian each verify that they have read and understand the UME 4-H Code of Animal Science Ethics and the consequences of and penalties provided for violations of the Code.

1. Junior contestants (ages 8 to 10) may model only one outfit. Intermediate members (ages 11 to 13) may model two outfits – one from Constructed and one from Ready to Wear. Senior members (ages 14 to 18) may model two outfits, but no more than one outfit per class.
2. Participants must participate in both the Preliminary and On-Stage Judging portions of the event.
3. Senior champions will represent Carroll County at the Maryland State Fair. Intermediates and Juniors can model only at the Maryland State Fair. 4-H members are responsible to registering themselves into the Maryland State Contest by July 31st at www.marylandstatefair.com
4. Each participant will need to arrive between 2-4pm on June 11th for modeling/interviewing with the judges. Times will not be assigned and it's the responsibility of the participant to arrive during the judging time listed above.
5. All classes except Ready to Wear are constructed by the 4-Her using a sewing machine, hand stitching, weaving, knitting or crocheting. These garments are completed as part of the Sewing/Textiles unit. As in the past, the entire outfit does not have to be home constructed,

unless described as a requirement for the class. Construction is judged only as it affects the appearance of the outfit on the model.

6. Ready to Wear classes are garments constructed by a manufacturer. No home-constructed items may be entered in these classes. Garments do not have to be purchased new and can be altered. You are encouraged to follow class descriptions as you select the appropriate class for your entry.

7. Accessories do not need to be made by the contestant, but will be taken into consideration in judging the overall presentation of the outfit. Accessories must be easily worn or carried. No live animals or people as accessories.

8. No one will be permitted on stage or in the judging room area unless pre-entered in the County Fashion Revue event.

9. Age divisions are determined as of January 1 of the current year; Division A–Clover (5-7 years old) Division C–Intermediate (11-13 years old) Division B–Junior (8-10 years old) Division D–Senior (14-18 years old)

10. Two top 13 year olds will be selected by the judges to participate in the State Fashion Revue as an educational opportunity.
